Protection in District: Dave suggested that we table the discussion until next month to look at

what entities that are in the district that are not compensating the

district for fire protection services. Commissioners agreed.

Chief Updates: 165 calls last year. The most active categories were:

13 building fires - 24 vehicle accidents - 21 smoke reports 14 unauthorized fires - 12 powerlines down

Bill Paul, Justice Branes, Dick Long, Nick Ness, and Dana Cross were the volunteers that reported the most often to our incidents.

Bill attended a discussion about an earthquake event. We'd likely be without outside resources for seven to ten days. There will be 'islands' where people won't be able to get across rivers. We have 10,000 meals of emergency food here at the Forks station.

The Forks Firehall, because it's concrete, needs an assessment. (Recommended) Bill reported on the hose tower, there is degradation of the concrete. We're cleaning up broken debris (concrete) weekly.

In a severe scenario, we could be without power for up to a year.

Structure Fire 1/1/16: A good response, a lot of good cooperation with law enforcement, the

county fire investigator. Justice did a great job on the investigation. Bill reported that the training we've conducted had good results for an actual incident. Upon arrival it wasn't certain if there were any

occupants inside.
