**Secretary – continued:** Chet moved to that we hire a part time person, salary \$12-\$17/hr.,

averaging 5-10 hours a week. Hours not to exceed 40 hours per month.

It will be put in a form of a resolution.

It will cost approximately \$800 in salary per month, plus payroll costs.

**Benefits:** Public Employees Benefits Board (PEBB) will allow us to enroll through

them at a cost of about \$718 per month. As defined by PEBB, employees pay for part of the coverage. Dave moved and Chet seconded to adoption Resolution #20016-0056 requesting enrollment

be approved. Motion unanimously carried.

Dave moved and Giancarlo seconded that LEOFF Resolution 2016—0057

to document decision to use LEOFF pension be moved. Motion

unanimously carried.

Dave moved that we enroll in Deferred Compensation by WA ST Dept.

of Retirement at \$350 under Resolution 20016-0058 and Chet

seconded. Motion unanimously carried.

**NEW BUSINESS:** 

**Investments:** Gerry asked about maturity dates on the investments. We have been

using WGEP, we have two certificates slightly over \$118,000, one maturing in May 2016 and the other maturing in May 2017. These investments can be withdrawn at any time without penalty, unlike

offerings at other financial institutions.

**Draft Emergency Mgmt Res.:** Bill is working with other agencies in the community and work on

developing a plan. After we have a plan started, we will compare notes

with District #3 and make sure we are not missing anything

**Undie Road:** We have an old pump that we put back in service out on site. They

would not be able to suppress any interior fires. He met with Bill Robinson from Jefferson Co. They are repairing the road. We are now

able to get in to the properties.

**Chief Updates:** We are still waiting to hear on our grant application to get more hoses.

We had all of our trucks serviced this last week. The Spartan truck had the pump's bolts are broke off. Having problem with one of the power steering units. Bill is checking it weekly and so far it's holding. If you fabricate something, it must be designed by a licensed engineer.

T91 needed a new water pump.

Red Cross emergency preparedness session went well.

Pagers, we received some donated that were UHF frequency and not compatible with our system.

We are going to get radios donated and issue those instead of pagers.

Emergency Reporting System Webinar: Entering pre-fire plans in the system.

Lowell asked what is planned, including high-cost acquisitions. Bill said nothing was planned. Deb noted that we will need a copier. Discussed having a copier located at Beaver. Also considered having WiFi. Giancarlo moved, Lowell seconded that we get an All-In-One printer and WiFi at Beaver. **Motion unanimously carried.** 

Chet moved Giancarlo seconded that we officially set the meeting to be held at Beaver. Motion withdrawn.

Discussion about meeting and being available for the majority of the constituents, along with business needs to hold the meeting at the Forks Station,

Meeting will be at Beaver next month. Notices and ad will be placed.

Deb will send Giancarlo public meeting materials to review until a session can be done with the new person to be the secretary.

**Extrication Training:** Wes and Ty went to training on using the JAWS and managing scene.

They cut up 62 cars. Cars manufactured starting in 2017 will have all tempered glass. Some of the newer vehicles can't be cut by the JAWS

because of the steel used in manufacturing..
